- 1. Call Meeting to Order Chair Kinney
 - Called to order at 7:00.

- 3. New
 - a. Child Development Services (CDS) cohort Director Bernstein
 - i. What is it?
 - 1. CDS is the quasi state education agency responsible for overseeing 0-5 young people.
 - 2. Maine is the only state that provides services under 5 outside of its public education structures. For many years, the state has been discussing how to change this. This is now taking place. Over four years, districts will be picking up students ages 3 and 4 as CDS will no longer exist. Our plan is to enter cohort 3, which is the 26-27 school year. All involved in special education leadership positions in the district will be involved in this transition planning.
 - 3. Questions?
 - a. Some students in PreK receive special education from CDS staff.
 - b. Who pays for services? The state. The idea of joining cohorts; all services provided for 3 and 4 year olds will be fully funded by the state. It is based on a formula.

- c. The law is written to provide services for students 3-22. It will allow us to connect with students earlier and receive services earlier through our district. CDS identifies kids for Sped Services, but is not always able to follow-through with services.
- d. How will we be able to provide those services? The plan will be to collaborate with childcare facilities to do so, but we will need to find staffing.
- e. What type of services? All special education programming including SDI, and speech therapy. For three year olds, we will need to provide services but not full programming in a classroom. For those not in childcare, we would need to provide a location for services. We need to think carefully about what parents are used to, which is choice (through Part C in the regs). We will need to have different structures.
- f. There are many questions that will be asked at a meeting with state reps next week. We will share updates as we gather information.
- g. This will be good for our kids when the process is implemented and a transition is eliminated.
- h. It will be good to implement the picking up of these responsibilities and students over two years with the cohort 3 model and not all in one year with cohort 4.
