RSU 9 Current Snapshot

38 students identified: CBS=8, CCHS=5, FTC=1, MBHS=5, MBMS=8, WGMS=7, AHS=4

Services provided: Immediate enrollment, Choice of the school of origin, Emergency housing, School Supplies, Clothing, Jackets, Sneakers, Referral to local resources

Who Qualifies for a 504 Plan?

There are three prongs the 504 team must consider when determining eligibility for a 504 Plan. The first prong is a diagnosed mental or physical impairment/disability. The diagnosis can come from a physician, or the school can evaluate. Section 504 defines a person with a disability as any person who: 1) Has a physical or mental impairment that substantially limits one or more major life activities; or 2) Has a record of such an impairment; or 3) Be regarded as having such impairment.

What's in a 504 plan?

504 plans often include accommodations. These can include:

- Changes to the environment (like taking tests in a quiet space)
- Changes to instruction (like checking in frequently on key concepts)
- Changes to how curriculum is presented (like getting outlines of lessons)

Accommodations don't change what students learn, just how they learn it.

Discriminatory Practices

- Penalizing a student whose absence is related to disability
- Suspending a student for behavior related to disability
- Not permitting 504 students to participate in intramural activities
- Not providing accommodations for student to attend field trips
