Therapy Dogs in Schools

The school district recognizes the use of therapy dogs has academic, social, and emotional benefits for students and staff. The Board authorizes the presence of therapy dog teams on school district property subject to the following provisions.

A. Certification

Proof of training and certification for the dog/handler team by a formal Dog Assisted Therapy organization, such as Love On A Leash (LOAL), Pet Partners (formerly Delta Society), Therapy Dogs International, Inc. (TDI), Alliance of Therapy Dogs (A.T.D.), or another formal organization approved by the Superintendent is required. A copy of the certification document(s) will be kept on file in the Central Office and on-site, preferably with the building principal and the dog handler (if the handler is a district employee).

B. Care

The handler shall be solely responsible for the supervision and care of the therapy dog, including any feeding, exercising, and cleaning up while the therapy dog is on school property.

C. License and Tags

All therapy dogs must meet local, county, and/or state license or permit regulations. It is required that therapy dogs have an owner identification tag in addition to a badge or other identifiers provided by the certifying agency. If an employee or outside provider approved by RSU 9 is bringing a dog to the school, a copy of the certifying badge/tag will be provided to Central Office, with another copy to be kept with the building principal.

D. Health

All therapy dogs must comply with local, county, and state vaccination and health requirements.

E. Liability

A copy of a current insurance policy that provides liability coverage for the therapy dog team must be provided by the certified handler and kept on file at the Central Office, with the building principal and the dog handler if they are a district employee.

F. Allergies and Aversions

The handler shall ensure the therapy dog will be in an assigned or separate area in instances where any student or school employee who suffers dog allergies or aversion is present.

G. Notification

Parents/guardians will be notified that a certified therapy dog may be on school grounds. Parents/guardians will be afforded the opportunity to notify school staff of any concerns. Information or concerns should be directed to the building principal and the handler of the dog.

H. Signage

Proper signage will be placed at the entrance to any RSU 9 district building in which a therapy dog is working.

I. Recordkeeping Handlers will sign their therapy dog in upon arrival and sign them out on their departure.

Research has shown that therapy dogs support psychological and academic growth, while increasing social skills and self-esteem in children and adolescents. Therapy dogs have been trained to provide emotional support which positively impacts reading skills, emotional functioning and communication skills. In addition, the use of therapy dogs may decrease anxiety, improve self-esteem and increase overall academic achievement in students.

We are very excited about the opportunity to have Rose work at our school! As a therapy dog team, Rose will always be in the presence of Ms. Mattens. Students might get in contact with Rose when walking in the hallway or working directly with Ms. Mattens.


