Mt. Blue Regional School District was notified that **9 (nine)** people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **64 (sixty-four)** close contacts were identified and have been notified. Of these close contacts, **11 (eleven)** are required to quarantine and **53 (fifty-three)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past 90 days.
