Health Notice #51

December 2, 2021

Mt. Blue Regional School District was notified that **5 (five)** people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **91 (ninety-one)** close contacts were identi and have been notified. Of these close contacts, **34 (thirty-four)** are required to quarantine and **57 (fifty-seven)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participat universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past days.

We are also notifying our school community that **Academy Hill School** has been designated in "Outbreak Status" by the Maine CDC. As a reminder, outbreak status is defined as three or more confirmed positive cases of COVID-19 among different households over a 14-day period. After consultation with the Maine CDC regarding this designation, we have determined there will be **no changes to the instructional model at Academy Hill School**.

Please be assured that our efforts to keep our schools safe continue and that our buildings are cleaned in accordance with all Maine CDC guidelines. *Please complete this form if you have any questions and would an RSU 9 staff member to reach out to you.* The number of cases and the impacted schools/locations are included below.
