Mt. Blue Regional School District was notified that **6 (six)** people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **67 (sixty-seven)** close contacts were identified and have been notified. Of these close contacts, **21 (twenty-one)** are required to quarantine and **46 (forty-six)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past 90 days.
