## Health Notice #38

November 12, 2021

Mt. Blue Regional School District was notified that **4 (four)** people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **36 (thirty-six)** close contacts were identified and have been notified. Of these close contacts, **8 (eight)** are required to quarantine and **28 (twenty-eight)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past 90 days.
