Mt. Blue Regional School District was notified that **7** (seven) people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **56** (fifty-six) close contacts were identified and have been notified. Of these close contacts, **35** (thirty-five) are required to quarantine, and **21** (twenty-one) are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past 90 days.
