Mt. Blue Regional School District was notified that **5 (five)** people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **98 (ninety-eight)** close contacts were identified and have been notified. Of these close contacts, **58 (fifty-eight)** are required to quarantine and **40 (forty)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past 90 days.
