Mt. Blue Regional School District was notified that **1 (one)** person associated with our district has tested positive for COVID-19. Contact tracing has been completed and **7 (seven)** close contacts were identified and have been notified. Of these close contacts, **1 (one)** is required to quarantine and **6 (six)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past 90 days.
