Health Notice #23

October 18, 2021

Mt. Blue Regional School District was notified that **3 (three)** people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **40 (forty)** close contacts were identified and have been notified. Of these close contacts, **23 (twenty-three)** are required to quarantine, and **17 (seventeen)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past 90 days.

Please be assured that our efforts to keep our schools safe continue and that our buildings are cleaned in accordance with all Maine CDC guidelines. *Please complete this* **form** *if you have any questions and would like an RSU 9 staff member to reach out to you.* The number of cases and the impacted schools/locations are included below.

We are also notifying our school community that **Cascade Brook School** has been designated in "Outbreak Status" by the Maine CDC. Outbreak status is defined as three or more confirmed positive cases of COVID-19 among different households over a 14-day period. After further consultation with the Maine CDC regarding this designation, we have determined there will be **no changes to the instructional model at Cascade Brook School.**
