# Health Notice #26

October 21, 2021

Mt. Blue Regional School District was notified that **3 (three)** people associated with our district have tested positive for COVID-19. Contact tracing has been completed and **49 (forty-nine)** close contacts were identified and have been notified. Of these close contacts, **34 (thirty-four)** are required to quarantine, and **15 (fifteen)** are allowed to attend school due to their meeting one of Maine CDC's exemptions: participate in universal masking, participate in pooled testing, are fully vaccinated, or were COVID-19 positive in the past 90 days.
