The summer is flying by, and school is just around the corner. I hope this finds you enjoying time with family and friends recharging your batteries! As we focus on the coming year it is time for me to share RSU 9 district updates with you.

Our 2<sup>nd</sup> Set of Water Testing Results – Came back to us last week. Upon <u>initial review</u>, I am pleased to say that it does not look like we have any water source or pipe issues, but we will need to replace several fixtures. We are working with a company to assist us with a deeper review of these results. We do not expect any disruption to the start of school. More detailed information will be shared next week.

Hiring – We continue to make progress with our hiring. We have hired a nice mix of new and veteran people along with multiple individuals with a close connection to our communities. The hiring market continues to be very competitive, and we are thankful for everyone who applied and for those who have agreed to join RSU 9! We are still in need of staff members in the areas of special education, especially support staff, Educational Technicians with 2 or 3 years of college, custodial services, and student transportation. **School Board & Superintendent Authority** – Some community members have asked whether School Board members or district administration have the authority to remove other School Board members from their elected office. This is a question with a clear answer: there is no legal authority for the RSU (or its administrators) to remove a duly elected School Board member. Communities that hold recall elections for school board members have provisions in their town charters that allow them to do so. Those with such provisions are very few in number.
